The Company invests for the long term and the Board has no intention of disposing of investments other than through takeovers, mergers or other exceptional circumstances that arise from time to time. If a provision for estimated capital gains tax in respect of unrealised investment portfolio gains was deducted, the above net tangible asset backing amount of \$33.05 would reduce to **\$27.49** (31 August 2015: \$27.47).

The calculation is based on the Company's interpretation of the law relating to capital gains tax and ASX Listing Rule 4.12.
